Tactical Conference was at the impressive United States Shooting Academy complex in Tulsa Oklahoma. Always a humbling and educational experience! Before beginning, I want to emphasize something that jumped out at me—shooting aftermath, are we prepared?

From Mas Ayoob's excellent lecture "Shooting Incidents; Aftermath Management": "Trainers who deemphasize dealing with the legal aftermath of a "justified" shooting are doing their students a disservice." ("We teach you to survive, that's all that counts.") Lack of preparation/training can lead to justified shooters making inappropriate statements to arriving LE personnel, or becoming the shootee when unprepared to

interact safely with the arriving officers. In that same vein, Marty Hayes discussed the Armed Citizens Legal Defense Network, LLC, in which he, Mas Ayoob, and other notable luminaries are involved. ACLDN benefits include education, legal support, lawyer and expert referrals and assistance with legal fees.

Paul Gomez noted in "Immediate Treatment of Trauma," generally, the "Platinum 10 Minutes" for someone injured in a violent encounter is long gone before the guys in the funny costumes with band-aids arrive. Arterial bleed-out can occur in less than five minutes, requiring Traumatic Injury training and a willingness to react.

Everyone who attends the Conference looks forward to the challenging shooting scenarios, but using two-hour blocks the eighteen lecturers,

including Marty, Mas, and Paul, make this conference the not-to-bemissed event. Proof was the tongue in cheek request to reduce the number of lecturers to make choosing classes easier! (A number of attendees actually chose not to shoot the competition for more lecture time.)

That said, here is a quick overview of the primer poppin' activities. Three outside stages included standards, with shots on multiple targets from 5 to 20 yards, a quick and dirty Dozier Drill on steel, and concluded with carrying a 30-pound baby to cover, engaging hostiles during and after the rescue.




The scenario-based shoot house stage placed the participant in a Mumbai-style situation, with impending execution. All targets for this were John Hearne's excellent, reactive Hard Head Ted, clothed and identified by carrying AK-47s. (Non-threats were the same, without guns.) Exhilarating and exhausting—as well as humbling! (There was also a backup gun side match, with distances out to 15-yards, which I could not squeeze in).

Lecture subjects varied from primer poppin' to stretching the mind and those stretching muscles. In the first, were Steve Moses "AK-47 Battlefield Pickup," USSA's Mike Seeklander "Wounded Shooter Drills," T. J. Pilling "Tactical Shotgun," Will Andrews "Moving and Shooting Handguns," and Rob Pincus and Paul White "Combat Focus Shooting."

In the second, lectures were presented by John Farnam "Urban



D., "Modern Psychology and Firearms Usage," Rangemaster Instructors John Hearne "Newhall Massacre and Its Training Implications" and William Aprill "Violent Actors, Violent Acts: An Overview," Marty Hayes "Reducing Firearms Instructor Liability." Skip Gochenour "Criminal Psychology," and Hany Mahmoud "Islamist Terrorist Groups: An Overview," In the muscle stretching, Southnarc "Managing Unknown Contacts" and USSA's Mike Brown's "The Clinch," were actually part one and two of the same subject. The first is how to avoid someone getting too close, with the latter dealing with someone who got too close!

sudden and non-stop. The "Check Look" many teach can be interpreted as a challenge, dealt with forcibly and immediately.

Meyer: Potential for the firearm type used to affect a jury's opinion is great and dependent on how long it is in front of the jury. Competent women and incompetent men are viewed harshest by juries!

Farnam: Leave the Aimpoint H-1

Tactical Response Videos



courses offered by TR, and not surprisingly, cover some of the material from the courses. (Disclaimer: No video can TEACH everything a course can. Seek competent instruction.)


The courses are intense, and these videos impart that feeling, as
